Notice of Public Hearing

Notice is hereby given that the Local Agency Formation Committee will hold a public hearing at 5:30 p.m. or as soon thereafter as possible, on March 24, 2010, to consider the following items:

- 1. Continued public hearing to consider and adopt the Mitigated Negative Declaration and exemption under CEQA Guidelines §15183(a) for, and annexation of, the Clarksville Professional Business Park to the El Dorado Irrigation District; LAFCO Project No. 2009-01. The annexation includes two parcels; 121-280-03 (9.5 acres), proposed for approximately ten commercial office/medical buildings and the Clarksville Cemetery, 121-280-05 (1.8 acres). The properties are located south of Highway 50 north of White Rock Road in the El Dorado Hills area. This item is continued from the February 24, 2010 LAFCO meeting.***
- 2. Public hearing to consider and adopt the Final LAFCO Budget, which projects the expenditures and revenues for Fiscal Year 2010-2011. The Proposed LAFCO Budget was approved by the Commission at the February 24, 2010 meeting and was distributed to all funding agencies per Government Code §56381.***

The Commission will meet in two concurrent meeting locations:

- Meeting Room in Building C, El Dorado County Government Center, located at 2850 Fairlane Court, Placerville, California 95667, and
- South Lake Tahoe City Council Chambers, located at 1901 Airport Road, South Lake Tahoe, California 96150,
