6. PUBLIC HEARING TO CONSIDER THE TAHOE PARADISE RESORT IMPROVEMENT DISTRICT "ACCELERATED REORGANIZATION" (CONVERSION) TO A RECREATION AND PARK DISTRICT (PROJECT NO: 2017-04)

The Tahoe Paradise Resort Improvement District (TPRID) Board of Directors is requesting to convert to a recreation and park district under special legislation in Government Code §56853.6 [Senate Bill 1023 (Wiggins, 2010)], which specifically authorizes the accelerated reorganization of TPRID into a recreation and park district in order to operate under a more modern principal statute. TPRID is located in the south Tahoe Basin in the Meyers area, along Highway 50 between the intersection of Highways 50 and 89 and the City of South Lake Tahoe.

Recommended Action: Open the public hearing on this matter and approve the accelerated reorganization, per staff recommendation.

7. PUBLIC HEARING TO CONSIDER AMENDING THE 2017-2018 BUDGET

Amendment to the FY2017-18 budget to authorize two previously unexpected expenditures. The fist is to enter into an open-ended contract with Streamline to update and support the LAFCO website. The second is to authorize hiring a graphic artist to redesign the LAFCO logo. Both of these expenditures will not result in the increase the overall size of the LAFCO budget and will be absorbed by forgoing other expenditures. This amendment will not result in additional contributions from the agencies' in El Dorado County.

Recommended Action: Adopt the amendment budget and Resolution L-2017-11.

8. CONSIDER AND APPROVE THE POSITION DESCRIPTIONS FOR TWO NEW LAFCO POSITIONS AND ADOPT A NEW SALARY RESOLUTION

Consideration of two new position descriptions for the agency. The staffing roles are that of the Assistant Executive Officer, a previously authorized position with no adopted description, and Assistant Policy Analyst, a new role that would essentially replace the Clerk role. With these two new positions, a new salary resolution needs to be adopted.

Recommended Action: Consider and adopt the new descriptions and Resolution L-2017-12.

9. CONSIDER AND APPROVE THE NINTH AMENDMENT TO THE EXECUTIVE OFFICER'S CONTRACT

The amendment to the EO's contract formalizes the process by which the EO can take a reasonable amount of unpaid time off after all other means of compensated time off have been exhausted, provided there is prior approval from the Commission Chair and so long as the time off does not interfere with the operations of the agency.

Recommended Action: Consider and adopt the Ninth Amendment
