## **RESOLUTION NUMBER L-2014-07**

### **Resolution Approving the Municipal Services Review and Sphere of Influence Study for Latrobe Fire Protection District and El Dorado Hills County Water District**

**LAFCO Project No. 2014-05**

**WHEREAS**, the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 governs the organization and reorganization of cities and special districts by local agency formation commissions established in each county, as defined and specified in Government Code Sections 56000 et seq. (unless otherwise indicated all statutory references are to the Government Code); and

**WHEREAS**, Section 56425 et seq. provides that the local agency formation commission in each county shall develop and determine the sphere of influence of each local governmental agency within the county, and enact policies designed to promote the logical and orderly development of areas within the spheres of influence, as more fully specified in Sections 56425 et seq.; and

**WHEREAS**, Section 56430 requires that local agency formation commissions conduct a municipal service review (MSR) prior to, or in conjunction with, consideration of actions to establish or update a sphere of influence (SOI) in accordance with Sections 56076 and 56425; and

**WHEREAS**, pursuant to Section 56430, in order to prepare and update the sphere of influence, the Commission conducted a Countywide Fire Suppression and Emergency Services Municipal Service Review and Sphere of Influence Study of Latrobe Fire Protection District and El Dorado Hills County Water District, and adopted a written statement of determinations in conjunction with this sphere of influence update on August 27, 2014; and

**WHEREAS**, the Executive Officer reviewed the sphere of influence update pursuant to the California Environmental Quality Act (CEQA), and recommended that the project is exempt from CEQA under Section 15061(b)(3) because it is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA, and, based thereon, the Executive Officer prepared a Notice of Exemption; and

**WHEREAS**, the Executive Officer set a public hearing for August 27, 2014 for consideration of the environmental review and the Municipal Service Review and Sphere of Influence Study of Latrobe Fire Protection District and El Dorado Hills County Water District and caused notice thereof to be posted, published and mailed at the times and in the manner required by law at least twenty-one (21) days in advance of the date; and

**WHEREAS**, on August 27, 2014 the Municipal Service Review and Sphere of Influence Study of Latrobe Fire Protection District and El Dorado Hills County Water District came on regularly for hearing before LAFCO, at the time and place specified in the Notice; and

**WHEREAS**, at said hearing, LAFCO reviewed and considered the Municipal Service Review and Sphere of Influence Study of Latrobe Fire Protection District and El Dorado Hills County Water District, and the Executive Officer's Report and Recommendations; each of the policies, priorities and factors set forth in Government Code Section 56425 et seq.; LAFCO's Policies and Guidelines related to spheres of influence, starting with Policy 4.0; and all other matters presented as prescribed by law; and

**WHEREAS**, at that time, an opportunity was given to all interested persons, organizations, and agencies to present oral or written testimony and other information concerning the proposal and all related matters; and

**WHEREAS**, the Commission received, heard, discussed, and considered all oral and written testimony related to the sphere update, including but not limited to protests and objections, the Executive Officer's report and recommendation, the environmental document and determinations and the service review; and

**WHEREAS**, the Commission does hereby make the following determinations regarding the proposal pursuant to Government Code Section 56425(e) in Section V of the Municipal Service Review and Sphere of Influence Study of Latrobe Fire Protection District and El Dorado Hills County Water District.

**NOW, THEREFORE, BE IT HEREBY RESOLVED, DETERMINED, ORDERED AND FOUND:**

Section 1. Each of the foregoing recitals is true and correct.

Section 2. The Notice of Exemption prepared by the Executive Officer is approved as the appropriate environmental document for this project.

Section 3. The El Dorado Local Agency Formation Commission adopts the Municipal Service Review and Sphere of Influence Study of Latrobe Fire Protection District and El Dorado Hills County Water District as set forth in Exhibit A attached hereto and incorporated herein by this reference, including all written determinations and recommendations as set forth therein.

Section 4. Pursuant to Government Code Section 56425(i)(2), the Commission does hereby establish the functions and classes of services provided by Latrobe Fire Protection District and El Dorado Hills County Water District as specified in Section V of this study.

Section 5. The updates to the spheres of influence for Latrobe Fire Protection District and El Dorado Hills County Water District are orderly, logical and justifiable.

Section 6. The Executive Officer is directed to file a Notice of Exemption under Section 15061(b)(3) in compliance with the California Environmental Quality Act and local ordinances implementing the same.

Section 7. The spheres of influence for Latrobe Fire Protection District and El Dorado Hills County Water District are updated as shown on the respective maps, marked as Maps 11 and 12, attached hereto and incorporated herein by this reference.
