PROTEST OF CHANGE OF ORGANIZATION OR REORGANIZATION

In accordance with Part 3, Division 3, Title 5 of the California Government Code commencing with §56000 (Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000), the undersigned hereby protest the following change of organization or reorganization:

**Latrobe Fire Protection District Dissolution, Project No. 2014-03 and
Reorganization of the Latrobe Fire Protection District and Sphere of Influence to the El Dorado Hills County
Water District and El Dorado County Fire Protection District; LAFCO Project No. 2014-04**

The Latrobe FPD service area is located in the southwestern corner of El Dorado County, south of Highway 50, serving the greater community of Latrobe. The District is directly south of the El Dorado Hills CWD (EDH Fire) boundaries, and is bounded on the west and south by the Sacramento and Amador County lines, respectively.

Protests may be made on behalf of a private corporation which is an owner of land by any officer or employee of the corporation without written authorization by the corporation to act as agent in making that protest.
