## NOTICE OF PUBLIC HEARING

Notice is hereby given that the El Dorado Local Agency Formation Commission (LAFCO) will hold a public hearing at 5:30 p.m. or as soon thereafter as possible, on May 25, 2022 in the Board of Supervisors Hearing Room in Building A, El Dorado County Government Center, located at 330 Fair Lane, Placerville, California 95667.

The public hearings scheduled for the May 25, 2022 meeting are as follows:

1. Consider and adopt CEQA Categorical Exemption §15319 for the Pacileo Annexation into the El Dorado Irrigation District (EID); LAFCO Project No. 2021-03. The owners of APN 092-060-055 submitted a landowner petition to LAFCO to annex their 0.83-acre property into EID in order to obtain water service for an existing single-family residence with a failed well. LAFCO approved an emergency out-of-agency service agreement between EID and the landowners on February 24, 2021 in anticipation of annexation. The property is located at 5290 China Hill Road, approximately one quarter mile west of the intersection with State Highway 49, south of Pleasant Valley Road, in the El Dorado area.
2. Public hearing to consider and adopt the Final LAFCO Budget, which projects the expenditures and revenues for Fiscal Year 2022-23. The Proposed LAFCO Budget was approved by the Commission at the February 23, 2022 meeting and was distributed to all funding agencies per Government Code §56381.

Meeting materials will be available five days before the meeting. Any person may submit oral or written comments. Staff will distribute written comments to the Commission if submitted 24 hours before the meeting.
