



PROTEST OF CHANGE OF ORGANIZATION OR REORGANIZATION

In accordance with Part 3, Division 3, Title 5 of the California Government Code commencing with §56000 (Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000), the undersigned hereby protest the following change of organization or reorganization:

**El Dorado County Fire Protection District Island Annexation
 LAFCO Project No. 2020-01**

On March 24, 2021, the Commission approved the above project, initiated by resolution of the El Dorado County Fire Protection District (EDCFPD) Board of Directors. The project annexes 14 separate "island" areas (159 parcels, 5,448 acres), in order to extend fire protection and emergency medical services to areas not currently within EDCFPD boundaries. The islands are completely surrounded by current EDCFPD boundaries, and are located in Cool, Pilot Hill, Shingle Springs, Placerville, Camino, and Pollock Pines.

Pursuant to the Governor's Executive Order N-29-20 (March 17, 2020), the Commission will hold this meeting by teleconference. More information regarding public access to the meeting will be available with the publication of the meeting agenda.

Only protests dated and received between the date of publication of the hearing notice and the conclusion of the protest hearing will be considered to determine the value of written protest.

Protests may be made on behalf of an owner of land by an agent authorized in writing by the owner to act as agent with respect to that land. Signed authorization must be provided with the protest. Protests may be made on behalf of a private corporation which is an owner of land by any officer or employee of the corporation without written authorization by the corporation to act as agent in making that protest.
